News from International Emmaus & Chrysalis

Certified Trainers

Our office has begun a new system for training Certified Trainers and we are beginning with Chrysalis in the North East Region. In the past, we have asked persons who are requesting to become Certified Trainers in Emmaus and Chrysalis to come to Nashville to be certified. With rising costs affecting all regions, we have decided to take the training to the regions. The very first trial run for this program will take place in Pennsylvania on October 31 to November 2, 2008. We are beginning with Chrysalis and once we have the kinks worked out, we will be offering it nationwide to both Chrysalis and Emmaus people who are interested.

Purple Worship Booklets

We are still hoping to have the new Purple Worship Booklets available by the end of the year. We are also making changes to the Blue Chrysalis Worship Booklets too. Our goal is to make the Holy Communion for both booklets contain the same service liturgy and to bring the Emmaus booklet up-to-date. It has remained almost completely the same since 1981. We will keep you informed as to the progress of these Worship Booklets and let you know when they are ready for ordering

Ed. note: This is just some of the wealth of information about Emmaus and Chrysalis on the web. Our 'Internet Links' page also provides access to on-line vendors where you can order Emmaus and Chrysalis publications and themed articles (e.g., shirts, hats, stickers, aprons, pens, etc.; Walk and Flight-based materials such as Director Manuals and Talk Outlines, however, are only available through our respective local NC/NEC Boards).

The International Emmaus and International Chrysalis sites also contain information about clergy qualifications for the Board as well as for Walks and Flights.

Community Elections

As provided for in our new bylaws, this November/December, the Community will elect, by mail, five Directors to serve on the Board of Directors for three year terms beginning in January 2009. You will find a biography for each of them on page 3. We all need to thank the seven candidates for agreeing to run and to pray for their service.

If you receive a paper newsletter, it contains a ballot for each Community member the Community database shows at your address, along with instructions about voting. If you get your newsletter on-line, you will receive similar ballot(s) and instructions by surface mail. In both cases, you will need to return the ballot(s) by surface mail.

Please remember, you don't need to serve as a Board member to help the Community. Contact the Community Lay Director, Nancy Baker, at comld@ncnec.org, or, 775-722-7292, with your ideas for service.

The bylaws provide for fifteen Directors to be elected by the Community for three-year terms. Each year we will elect five to replace those who have served their terms. Thus in 2011, we will have seated these fifteen Directors under the new rules.

The Community elects Directors to the board, but not by position. The Board determines, with some guidance from the bylaws, who serves in what position.

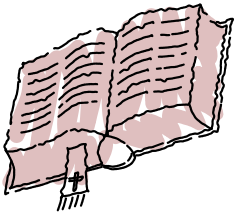
